# **Pod Lifting Frame**



#### **Product Information**

## **Overview**

The Conquip Pod Lifting Frame is used in situations where the use of a CantiDeck is not feasible. It enables prefabricated modular pods to be transported into a building structure.

Integrated attachment points on the floor of the frame ensure the pod can be safely secured and lifting points in each corner allow for quick and easy attachment. Once lifted to the desired level, the frame can be secured using the attachment points on the beams and anchor points within the building.


The ramp sits on the slab edge which allows the pod to be smoothly and easily transferred from the Pod Lifting Frame into the building.

### **Key Benefits**

- The frame incorporates integrated attachment points to secure the pod in the frame and to secure the frame to the building structure.
- The frame doors lock into place as an extra safety precaution.
- It comes equipped with 4 lifting points that provide greater stability during lifts and allow for quick and easy connection to a 4 leg chain.
- Manufactured in the UK from quality British and EU steel.






# **Usage Instructions**

#### **Important Usage Notes**

- The Pod Lifting Frame must only be lifted by the designated four lifting points.
- The Pod Lifting Frame is for lifting and transporting pods only. DO NOT use to raise or transport personnel.

### **Usage Instructions**

1. Create an exclusion zone at ground level.




2. Then create an exclusion zone within the building prior to lifting.



# **Usage Instructions**

3. Attach a suitable rated chain sling that will withstand the weight of the pod and the Pod Lifting Frame.




- 4. Check the dimensions of the pod against the internal dimensions of the Pod Lifting Frame prior to loading.
- 5. Load the Pod Lifting Frame with the pod using the access doors. If loading from above, the internal dimensions will reduce. Please refer to the 'Clear Area' dimensions in the specification drawing on page 4.



- 6. Secure the load, using the integrated attachment points.
- 7. Ensure the doors are fully closed and the pin is in the locked position before lifting.
- 8. Once the supervisor is happy that the load is secure, balanced, and does not

- exceed maximum loading weights, attach a suitable rated chain sling to the end of the four lifting single lifting chains at each of the corners of the frame.
- 9. Check that personnel are clear from the immediate area and the future location to allow for swing of the frame when lifting off the ground.
- 10. Ensure tag lines are attached to the Pod Lifting Frame.
- 11. Carefully raise the frame just off the ground and check for balance and security.



- 12. Crane lift the frame to the required level of the building or structure.
- 13. Guide into place using the tag lines and lower until the ramp is resting on top of the slab edge and the frame is flush to the building.

14. Secure the frame to the building by fastening ratchet straps to the integrated attachment points on the Pod Lifting Frame and designated anchor points in the building.




- 15. Before unloading the pod, consider risk assessment and ensure necessary safety steps have been taken to allow personnel to access a suspended load.
- 16. Keep the crane fixed during offload.
- 17. Once the Pod Lifting Frame is secure, open the doors and unload the pod from the frame.

18. After the pod has been unloaded and all personnel are clear of the Pod Lifting Frame, unhook the ratchet straps to release it from the building and replace the edge protection on the building's edge.



- 19. Lower the Pod Lifting Frame onto a firm, stable, flat surface.
- 20. Once you have finished using the Pod Lifting Frame, detach it from the lifting equipment.

# Original Working Instructions **Safety Instructions**

#### **Basic Safety**

A site-specific Risk Assessment, and lift plan where applicable, must be completed by the responsible person before using this equipment to control risks, produce a safe system of work and ensure safety for you, your colleagues and others. Your risk assessment will determine the correct Personal Protective Equipment (PPE) for the task you are doing. You must use it. Conquip recommends that you should wear:

- Suitable clothing
- Gloves
- Hard hat
- Protective footwear (steel toecaps)
- · Safety glasses











#### **Important Safety Notes**

- Read these instructions before using this equipment. If there is anything you do not understand
  or if you have any concerns do not use this equipment. Contact your supervisor or Conquip
  Engineering Group for advice.
- You must check that you have considered all the safety requirements for the task you are doing and that this equipment is suitable.
- You must protect bystanders and the general public by preventing access to the working area.
- Do not use this equipment if you are tired, unwell or under the influence of alcohol or drugs. If
  you are taking any medicine or undergoing treatment you should inform your supervisor.

#### **Usage & Transportation**

- Never unevenly load this equipment.
- The weight of the equipment, together with its attachments, must be added to the weight of the load when calculating the total load that will be imposed on the lifting apparatus / operating machine.
- This equipment must be used in conjunction with the load ratings of the lifting apparatus / operating machine. (Refer to the manufacturers' load ratings and original working instructions).
- Make sure you know how to use this equipment and understand all aspects of its operation in case of emergency.
- This equipment weighs more than 25kg. Do not lift or manhandle without machine assistance.
- Do not operate this equipment near overhead power lines.
- Take care in confined spaces, near ceilings or similar hazards. This equipment was designed for vertical lifting. Do not drag, or swing.
- Before operating this equipment, check that you have enough space for you to work safely and make sure that the working area is clear of hazards, obstructions and personnel.
- Before lowering equipment make sure that the landing zone is clear and capable of accepting the size and weight of the load.
- Crush Risk. Keep hands and feet clear of the equipment at all times to avoid injury.
- Do not exceed the maximum Working Load Limit (WLL) shown on the serial plate. Ensure that the WLL
  on the individual lift points is not exceeded.
- Before lifting, check that the load is secured, balanced and stable. Allow space for the equipment to move if the load shifts.

#### **Personnel**

- All personnel must wear relevant personal protective equipment.
- Do not wear loose clothing or jewellery and tie back long hair to avoid becoming tangled or trapped in this equipment. You must make everyone in the work area aware of what you are doing.
- All personnel involved in the lifting operation must be competent to do so and must have been briefed
  in conjunction with this User Guide available from Conquip Engineering Group, the manufacturer.

#### **Equipment Maintenance & Cleaning**

- It is mandatory that the equipment is thoroughly examined regularly, by a qualified engineer, to ensure
  compliance with relevant regulation/s. (Conquip recommend to carry out thorough examination every
  six months).
- This product may incorporate various loose and detachable items of lifting gear. Refer to the separate requirements for the safe use of those items.
- When not being used, store the unit in a clean, upright condition and in a safe place where it will be
  protected from thieves and unauthorised users.
- This equipment must be inspected by the responsible person before each use and then regularly, as
  determined by your risk assessment or working practice. If you have any concerns about condition or
  suitability do not use.
