Overview

The Conquip Boat Skip is for general muck and waste removal, the heavy-duty design making it ideal for transporting heavier loads, low loading height and drop-down bale arm making loading very easy.


Designed with slotted bale arm, lifting point and latch for automatic emptying of the skip by the crane operator, it eliminates the need for an assistant to manually operate.

Key Benefits

- Automatic unloading eliminates the need for an assistant and for the slinger / signaller to enter the 'danger zone'.
- Lifts and tips part loads, a physical impossibility with traditional, manually operated, circular muck skips.
- Available in a wide range of capacities, from 500 to 6000 litres.
- Available with a debris cover to keep dust pollution to a minimum.



Usage Instructions

CA108 Important Usage Notes

- When attaching to lifting equipment always ensure that the hook's gate is correctly closed and the lifting eye is seated correctly in the hook.
- Do not use the boat skip for carrying toxic or dangerous materials or chemicals or light fires in or around the skip.
- Do not overfill the skip by volume or weight, the load should be evenly placed.
- At no point during the operation of this skip should personnel be within the discharge zone.
- All of the lifting, tipping and manoeuvring must be carried out by a crane. Do
 not attempt to move the skip of the bale arm by hand.
- The Boat Skip is for lifting and transporting waste and materials only. Do not use to raise or transport personnel.

CA108 Automatic Locking Mechanism Instructions


- 1. The CA108 self-discharging Boat Skip is fitted with a lock and release system. The lock is situated at the rear of the skip and engages with the catch fitted to the top of the lifting arm.
- 2. When the lifting arm is lowered fully, it will engage with the locking system. When next raised, the skip will rise and discharge its load.
- 3. When fully lowered a second time, the lifting arm will disengage from the locking system allowing the unit to be raised and manoeuvred to the loading bay.
- 4. If the lifting arm is out of sequence (locked when it should be unlocked) simply raise the lifting arm then lower to release the catch.


CA108 Loading, Moving and Emptying Instructions

- 1. Attach the lifting equipment's hook to the skip's bale arm lifting point, with the bale arm in the lowered position.
- Carry out a test lift with the unit empty to ensure that both the slinger / signaller and the crane operator are familiar with the correct and safe operation of the boat skip and fully understand how the locking mechanism functions, the tipping action is carried out and the reactions of the skip to these actions.
- 3. Raise the crane to bring the lifting arm upright and lift the unit just off the ground.
- 4. Check that the skip is balanced correctly before lowering back to the ground. The Boat Skip is now ready for use.
- 5. Position the unit on firm level ground, which is able to bear the unit's weight and load. Lower the bale arm.
- 6. Evenly fill the skip, ensuring the load is no wider, longer or higher than the skips side walls.
- 7. Cover the load in the skip with a debris cover, by pulling the cover over the load and fasten on all four sides by hooking the rope around each of the welded hooks. It is recommended that the load is covered with a debris cover to safeguard against any of the load falling from the skip.



CA108 Loading, Moving and Emptying Instructions Continued

8. Once loaded and ready, clear all personnel from the area, and raise the skip off the ground to check that the load is balanced and secure. The skip can now be craned to the discharge area.



- Ensure that no personnel are in the discharge area, lower the skip to the ground with the front facing the discharge area.
- 10. Lower the lifting arm fully to allow the locking system to engage.
- 11. Remove the debris cover.







- 12. Once ready, raise the lifting hook to tip the skip and discharge the load.
- 13. Having emptied the skip, lower it back to the ground to allow the lifting arm to disengage from the locking system before once again raising the skip and moving to the loading area.

CA122/CA138 Important Usage Notes

- Bale arm is fitted with a safety chain (CA122) or a safety latch mechanism (CA138) to ensure it can be safely stored in an upright position.
- When attaching to lifting equipment always ensure that the hook's gate is correctly closed and the lifting eye is seated correctly in the hook.
- Do not use the boat skip for carrying toxic or dangerous materials or chemicals or light fires in or around the skip.
- Do not overfill the skip by volume or weight, the load should be evenly
- At no point during the operation of this skip should personnel be within the discharge zone.
- All of the lifting, tipping and manoeuvring must be carried out by a crane. Do not attempt to move the skip of the bale arm by hand.
- The Boat Skip is for lifting and transporting waste and materials only. Do not use to raise or transport personnel.

CA122/CA138 Automatic Locking Mechanism Instructions


- 1. The CA122/CA138 self-discharging Boat Skip is fitted with a hook and catch locking and release system. The hooks are located on both sides of the bale arm and the catches are situated on both sides of the skip body.
- 2. The hooks engage with the catches as the bale arm is lifted upward and towards the front of the skip and will remain in place until the skip is landed and the bale arm lowered.
- 3. When the bale arm is lowered ensure the catch does not engage so that the centre of gravity ensures that the skip will then lift in the tipping position.




Usage Instructions

CA122/CA138 Loading, Moving and Emptying Instructions

- 1. Attach the lifting equipment's hook to the skip's bale arm lifting point, with the bale arm in the lowered position.
- Carry out a test lift with the unit empty to ensure that both the slinger / signaller and the crane operator are familiar with the correct and safe operation of the boat skip and fully understand how the locking mechanism functions, the tipping action is carried out and the reactions of the skip to these actions.
- 3. Raise the crane to bring the bale arm upright so the hooks engage with the catches.








- 4. Carefully raise the skip just off the ground.
- 5. Check that the skip is balanced correctly before lowering back to the ground. The Boat Skip is now ready for use.
- 6. Position the unit on firm level ground, which is able to bear the unit's weight and load. Lower the bale arm.
- 7. Evenly fill the skip, ensuring the load is no wider, longer or higher than the skips side walls.
- 8. Cover the load in the skip with a debris cover, by pulling the cover over the load and fasten on all four sides by hooking the rope around each of the welded hooks. It is recommended that the load is covered with a debris cover to safeguard against any of the load falling from the skip.
- 9. Once loaded and ready, clear all personnel from the area, and raise the bale arm bringing the lifting eye towards the front of the skip.
- 10. The bale arm will hit the stops when it reaches the correct lifting position. Note the angle of the bale arm and the position of the pivot points.

CA122/CA138 Loading, Moving and Emptying Instructions Continued

- 11. Raise the bale arm carefully ensuring the angle of the bale arm is maintained, the hooks will lock into the catches, the skip is now ready to be lifted.
- 12. Raise the skip just enough to allow sufficient clearance from the ground to ensure the load is balanced and secure. The skip can now be crane lifted to the discharge area.
- 13. Ensure that no personnel are in the discharge area, lower the skip to the ground with the front facing the discharge area, note the position of the pivot points as the hooks slide down from the catches. Remove the debris cover.
- 14. Position the crane towards the rear of the skip and raise the bale arm carefully ensuring the hooks do not engage with the catches. As the bale arm is lifted, the skip will tip forward and begin to discharge.







- 15. Raise the lifting hook as necessary to empty the skip completely.
- 16. The skip can now be lowered to its resting position.
- 17. Once empty and lowered, lower the bale arm to its lowered position and detach it from the lifting equipment.

Safety Instructions

Basic Safety

A site-specific Risk Assessment, and lift plan where applicable, must be completed by the responsible person before using this equipment to control risks, produce a safe system of work and ensure safety for you, your colleagues and others. Your risk assessment will determine the correct Personal Protective Equipment (PPE) for the task you are doing. You must use it. Conquip recommends that you should wear:

- Suitable clothing
- Gloves
- Hard hat
- Protective footwear (steel toecaps)
- Safety glasses











Important Safety Notes

- Read these instructions before using this equipment. If there is anything you do not understand or if you have any concerns do not use this equipment. Contact your supervisor or Conquip Engineering Group for advice.
- You must check that you have considered all the safety requirements for the task you are doing and that this equipment is suitable.
- You must protect bystanders and the general public by preventing access to the working area.
- Do not use this equipment if you are tired, unwell or under the influence of alcohol or drugs. If you are taking any medicine or undergoing treatment you should inform your supervisor.

Usage & Transportation

- Never unevenly load this equipment.
- The weight of the equipment, together with its attachments, must be added to the weight of the load when calculating the total load that will be imposed on the lifting apparatus / operating machine.
- This equipment must be used in conjunction with the load ratings of the lifting apparatus / operating machine. (Refer to the manufacturers' load ratings and original working instructions).
- Make sure you know how to use this equipment and understand all aspects of its operation in case of emergency.
- This equipment weighs more than 25kg. Do not lift or manhandle without machine assistance.
- Do not operate this equipment near overhead power lines.
- Take care in confined spaces, near ceilings or similar hazards. This equipment was designed for vertical lifting. Do not drag, or swing.
- Before operating this equipment, check that you have enough space for you to work safely and make sure that the working area is clear of hazards, obstructions and personnel.
- Before lowering equipment make sure that the landing zone is clear and capable of accepting the size and weight of the load.
- Crush Risk. Keep hands and feet clear of the equipment at all times to avoid injury.
- Do not exceed the maximum Working Load Limit (WLL) shown on the serial plate. Ensure that the WLL on the individual lift points is not exceeded.
- Before lifting, check that the load is secured, balanced and stable. Allow space for the equipment to move if the load shifts.

Personnel

- All personnel must wear relevant personal protective equipment.
- Do not wear loose clothing or jewellery and tie back long hair to avoid becoming tangled or trapped in this equipment. You must make everyone in the work area aware of what you are doing.
- All personnel involved in the lifting operation must be competent to do so and must have been briefed in conjunction with this User Guide available from Conquip Engineering Group, the manufacturer.

Equipment Maintenance & Cleaning

- It is mandatory that the equipment is thoroughly examined regularly, by a qualified engineer, to ensure compliance with relevant regulation/s. (Conquip recommend to carry out thorough examination every six months).
- This product may incorporate various loose and detachable items of lifting gear. Refer to the separate requirements for the safe use of those items.
- When not being used, store the unit in a clean, upright condition and in a safe place where it will be protected from thieves and unauthorised users.
- This equipment must be inspected by the responsible person before each use and then regularly, as determined by your risk assessment or working practice. If you have any concerns about condition or suitability do not use.
