

# Product Information **Overview**

The Conquip Block Grab is designed and manufactured to lift secure packs of blocks and bricks. It features an automatic mechanism that enables a single operator to stack or unstack secure loads.

The Block Grab is also suitable for handling all types of concrete products, such as slabs, steel strapped bricks, blocks, kerb stones and paving blocks.

### **Key Benefits**


- Automatic catch mechanism enables a single operator to stack or unstack secure loads.

# Original Working Instructions **Usage Instructions**

### **Important Usage Notes**

- This type of lifting equipment relies upon a 'crushing' force to grip the load prior to and during the lift. There will always be the possibility that the load (especially of soft materials) may break up and become unstable during the lift. You should therefore inspect each load prior to lifting, to ensure its suitability.
- Do not allow hands or feet to come between, or below the grab and the load.
- Do not attempt to adjust or manhandle a load whilst it is in a raised position.
- The grab arms should not be in contact with the ground. However, when lifting blocks, the grab arm should be no higher than 1/3 up the block.
- Always try to lift the blocks end on rather than the sides. The loads length must not be greater than the grab arms.
- Do not drag the load; this equipment is for lifting the load clear off the ground.

### **Using with Lifting Apparatus**

- 1. Attach the lifting apparatus' hook to the Block Grab's lifting point. Always ensure that the hook's gate is correctly closed.
- 2. Place the Block Grab on the ground making sure that its jaws are fully open.
- 3. Position the height of the contact wheels so that the distance from the grab jaws to the wheels is equal to the load's height.
- 4. The position of the wheels is adjusted by pulling out the pins to unlock, move the wheels up or down the arm height locator as required, then reinserting the pins to lock.
- 5. This adjustment must be carried out to equal setting on both sets of wheels. The grab is now ready to use.
- 6. Secure the pack to be lifted with banding. If not banded, when lifting stacked loads such as building blocks, the blocks may separate during the lift.
- 7. Raise the grab and position over the load, checking that it is centrally aligned before lowering.
- 8. Lower the grab until the automatic locking mechanism closes onto the load.


- 9. Raise the load just above the ground and check that the load is correctly balanced and secure.
- 10. Whilst the load is being held off the ground, fix a Safety Restraint Net. Pull the net under the loaded Block Grab, lift up around the outside of the Block Grab and secure the loops on the net to the safety net hooks. The net can be adjusted by pulling up any slack on to the hooks. Only use a tested and certified net, as supplied by Conquip Engineering Group.
- 11. Once the net is secured and the load is safe, proceed to move the load to its required position.
- 12. Move slowly and carefully; do not jolt the load.
- 13. When in position, lower the load until in contact with the ground. The grab jaws will automatically release and allow you to raise the Block Grab clear of the load.
- 14. You can now proceed to the next load.
- 15. An unloaded grab will alter between grip and release each time it receives a jolt. This may cause the jaws to be out of sync when you next attempt to 'grab a load'. If this is the case, lower the emptyl Block Grab to the ground to alter to the release position before reloading.

# Original Working Instructions **Safety Instructions**

### **Basic Safety**

A site-specific Risk Assessment, and lift plan where applicable, must be completed by the responsible person before using this equipment to control risks, produce a safe system of work and ensure safety for you, your colleagues and others. Your risk assessment will determine the correct Personal Protective Equipment (PPE) for the task you are doing. You must use it. Conquip recommends that you should wear:

- Suitable clothing
- Gloves
- Hard hat
- Protective footwear (steel toecaps)
- Safety glasses



#### **Important Safety Notes**

- Read these instructions before using this equipment. If there is anything you do not understand or if you have any concerns do not use this equipment. Contact your supervisor or Conquip Engineering Group for advice.
- You must check that you have considered all the safety requirements for the task you are doing and that this equipment is suitable.
- You must protect bystanders and the general public by preventing access to the working area.
- Do not use this equipment if you are tired, unwell or under the influence of alcohol or drugs. If you are taking any medicine or undergoing treatment you should inform your supervisor.

#### **Usage & Transportation**

- Never unevenly load this equipment.
- The weight of the equipment, together with its attachments, must be added to the weight of the load when calculating the total load that will be imposed on the lifting apparatus / operating machine.
- This equipment must be used in conjunction with the load ratings of the lifting apparatus / operating machine. (Refer to the manufacturers' load ratings and original working instructions).
- Make sure you know how to use this equipment and understand all aspects of its operation in case of emergency.
- This equipment weighs more than 25kg. Do not lift or manhandle without machine assistance.
- Do not operate this equipment near overhead power lines.
- Take care in confined spaces, near ceilings or similar hazards. This equipment was designed for vertical lifting. Do not drag, or swing.
- Before operating this equipment, check that you have enough space for you to work safely and make sure that the working area is clear of hazards, obstructions and personnel.
- Before lowering equipment make sure that the landing zone is clear and capable of accepting the size and weight of the load.
- Crush Risk. Keep hands and feet clear of the equipment at all times to avoid injury.
- Do not exceed the maximum Working Load Limit (WLL) shown on the serial plate. Ensure that the WLL
  on the individual lift points is not exceeded.
- Before lifting, check that the load is secured, balanced and stable. Allow space for the equipment to move if the load shifts.

#### Personnel

- All personnel must wear relevant personal protective equipment.
- Do not wear loose clothing or jewellery and tie back long hair to avoid becoming tangled or trapped in this equipment. You must make everyone in the work area aware of what you are doing.
- All personnel involved in the lifting operation must be competent to do so and must have been briefed in conjunction with this User Guide available from Conquip Engineering Group, the manufacturer.

#### **Equipment Maintenance & Cleaning**

- It is mandatory that the equipment is thoroughly examined regularly, by a qualified engineer, to ensure compliance with relevant regulation/s. (Conquip recommend to carry out thorough examination every six months).
- This product may incorporate various loose and detachable items of lifting gear. Refer to the separate requirements for the safe use of those items.
- When not being used, store the unit in a clean, upright condition and in a safe place where it will be protected from thieves and unauthorised users.
- This equipment must be inspected by the responsible person before each use and then regularly, as determined by your risk assessment or working practice. If you have any concerns about condition or suitability do not use.
